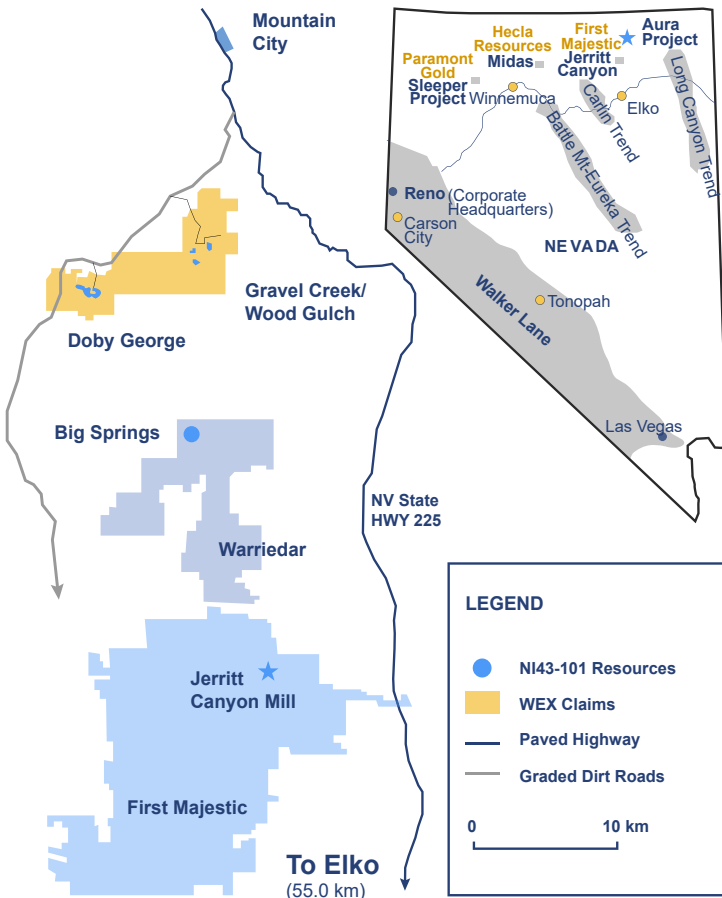

## Three Current, NI 43-101 Resources at Aura Project

### DOBY GEORGE

Near surface, at ~0.9 g/t oxide which could be fast tracked to a development decision within 18 months. Over 800 holes, open at depth.

### WOOD GULCH

Past producer, open pit heap leach. 1,500 m up dip of Gravel Creek with 1 km of untested ground between the two deposits (aka The Gap).

### GRAVEL CREEK

2023 drilling intercepts

- 0.7 meters of 143.56 g/t AuEq (138.82 g/t Au and 403.4 g/t Ag)
- 1.0 meter of 67.49 g/t AuEq (52.46 g/t Au and 1278.0 g/t Ag)
- 2.0 meter of 21.96 g/t AuEq (12.77 g/t Au and 781 g/t Ag)
